It was originally formed on September 2, 1977, as the ASEAN Inter-Parliamentary Organization (AIPO) by the leaders of the parliamentary delegations of Indonesia, Malaysia, the Philippines, Singapore, and Thailand attending the Third ASEAN Inter-Parliamentary Conference in Manila, Philippines. In 1995, Viet Nam became a member, followed by Lao People's Democratic Republic in 1997, Cambodia in 1999, Brunei Darussalam in 2009, and Myanmar in 2011. At the 27th AIPO General Assembly held in Cebu City, Philippines in 2006, there was a consensus to transform the organization into a more effective and closely integrated institution and to change the organization's name from AIPO to AIPA The information that we request will be retained by us and used as described in this privacy policy.
